




# A Peek Into How We Are Organized?

SLO Skiers, Inc.

Is a 501c3 Non-Profit Corporation - Incorporated on 10/30/1979

**We'll be 41 years old in October!**

**Here is a random short excerpt from our bylaws for your perusal.....**

## **5. MEMBERS**

### **5.1. Persons who are Members**

The Members of the Club shall consist of those natural persons who have meet the eligibility requirements set forth in Section 5.2 of this Article, who have paid dues and who have been enrolled as Members on the Membership roster. There shall be only one class of Members in the Club, and no person may hold more than one Membership.

### **5.2. Eligibility for Membership**

Membership in the Club shall be open to all individuals twenty-one (21) years of age or older who are interested in the sport of skiing and/or the other social and recreational activities of the Club.

### **5.3. Membership Dues**

Membership dues shall be due and payable on the first day of the fiscal year of the Club and shall be in such amounts as are determined from time to time by the Board of Directors. Dues paid at any time during the fiscal year shall entitle the payer to Membership only for the balance of that fiscal year.

### **5.4. Term of Membership; Rights and Duties of Members**

Memberships shall be valid for one year. Members shall have the right to vote to elect the directors of the Club, to nominate officers of the Club to be confirmed by the Board of Directors and to participate in Club activities, subject to any conditions and limitations prescribed by resolutions of the Board of Directors from time to time.

No Member shall acquire any interest in the income or assets of the Club. Memberships shall not be assignable by any Member, nor shall any Membership vest in any personal representative, heir or devisee as a result of the death of a Member.
